I request the upcoming management under leadership of the new President Mr. Ismail Asif to carry the flagship of SAARC CCI with more dynamism and enthusiasm.

## **Executive Summary**

The SAARC Chamber of Commerce & Industry (SAARC CCI) remained active during the term 2012-13 and till March 2014, under the chair of Mr. Vikramjit Singh Sahney.

During the term under review, SAARC CCI organized over all 26 activities including 20 seminars/conferences/ meetings and 6 Executive Committee Meetings in various member countries, as compared with 29 actives organized in the previous term i.e. 2010-2011. The Executive Committee Meetings were organized in similar number to the previous term. The major areas under focus were regional integration, Trade facilitation, socio-cultural exchanges, Women entrepreneurs and Youth development. The 5th SAARC Business Leaders Conclave (5th SBLC) was the landmark achievement of SAARC CCI wherein eight Commerce Ministers from all South Asian Countries graced the occasion with their presence and greatly helped in image-building of the organisation.

In addition to the activities organised under MoC with FNSt, the President SAARC CCI represented the organization at various regional and International Fora and had the privilege to interact and meet the Prime Ministers & President of Bhutan, India, Nepal and Pakistan and Finance Ministers of all South Asian Countries. His participation in various events has helped in institutional linkages and promotion of SAARC Chamber of Commerce & Industry in more profound manner. As members of Pak-India Joint Councils (which is represented by 8 members of SAARC CCI including President and VP Pakistan) SAARC CCI played an important role in promoting relationship between India and Pakistan.

In addition to continuing its partnership with China-South Asia Business Forum (Kunming) and Sichuan-South Asia Business Forum (Sichuan), SAARC CCI sought partnership with WIPO, resultantly it was invited by World Intellectual Property Organsation (WIPO) to Geneva at Study tour, comprising officials of the secretariats of all National Chambers. Similarly on issue of Bio-energy and carbon Standards, SAARC CCI participated in programs organised by Swedish International Standards (SIS) organisation and SIDA. SAARC CCI was well represented in 5th South Asian Economic Summit and signed MoU with CACCI to further expand scope of cooperation with other countries as well.

Particular attention was given on publication of post-event reports. In addition to bringing out 23 editions of SAARC Biz, 14 publications including post event reports and one Research Study "Financial Cooperation in South Asia" and market intelligence report "Investment in India" were published during the term under review as compared with 12 reports published in the previous term.

The term under review, witnessed a lot of improvement in relationship between SAARC Secretariat and SAARC CCI Secretariat. As a result of extensive correspondence and follow up on important matter, SAARC Secretariat invited SAARC CCI to make presentations on four important meetings/ group of experts, as compared with only two such invitations in the previous term. SAARC CCI was also provided an opportunity to interact and meet with Finance Ministers from all South Asian countries in May 2013 at New Delhi on the occasion of SAARC Finance Ministerial Moot, organised by ADB, wherein SAARC CCI presentation was appreciated by Ministers. This interaction was facilitated by SAARC secretariat, which speaks of improved liaison of SAARC CCI with its parent body.

Because of close working relationship, initiatives and input provided, H.E. Ahmed Saleem, Secretary General of SAARC issued a letter of appreciation to SAARC CCI, the first ever in the history of SAARC CCI. H.E. himself participated in five events of SAARC CCI.

Apart of that the issue of SAARC Visa sticker was strongly taken up with relevant authorities, inculding request letters to all Secretaries of Interior Ministers, submission of position paper to SAARC Secretariat and discussed the issue during call to Hon'ble Prime Minister of India by Commerce Ministers from South Asian countries on occasion of 5th SBLC, requesting to support our proposal for increasing SAARC stickers to 500 for each country on one-year basis.

As the result of extensive follow up, the request for increase in stickers is under review and hopefully will be executed in next meeting of Foreign Ministers before the upcoming SAARC Summit.

It is however, encouraging that under the revised "Guidelines and Procedures and Rights and Obligations of SAARC Apex Bodies" issued by SAARC Secretariat dated March 17, 2014, the spouses and children under 18 of the Exective Committee member of SAARC CCI shall be entitled for SAARC Visa Exemption Sticker. This was also one of the major demands of the SAARC CCI.

The under reviewed tenure (2012-2013) witnessed fair growth in terms of membership. A new organisation, Confederation of Indian Chambers of Commerce & Industry (CII) has been inducted in the SAARC Chamber's mechanism. During the term, 54 Life members were registered including 39 from Pakistan and 15 from India as compared with 98 members during the previous term. In addition to that, two applications (one each from Afghanistan and Nepal) are under process.

An encouraging growth in overall finances has been witnessed in all heads during the term.

In January 2012, capital income (Trust Corpse) was accounted for Pak Rs. 156.23 million, which increased to Pak Rs. 179.21 million. This shows a growth of 15.62%. The referred capital revenue includes Pak. Rs. 157 million, which has been placed under Term Deposit Account.

In term of revenue and expenditures, the year 2012 witnessed, a profit of Rs. 13.49 million (Rev=27.60 million, Exp= 14.11 million) while in year the expenditure were estimated at 13.66 million against revenue income Pak. Rs. 22.58, showing surplus of Pak Rs. 8.91 million.



#### **SAARC CCI Brief Introduction:**

Established in 1985, SAARC had hitherto avoided including core economic issues in its programme, but in the wake of the desire for a SAARC Chamber of Commerce and Industry, the SAARC Secretariat commissioned a study on Trade, Manufactures and Services in 1988. The study was completed in 1991 and strongly supported to establish a SAARC Chamber of Commerce and Industry to bring about improvement in the business environment disseminate information about potential tradable goods and identify joint ventures in the SAARC region.

Pursuant to the directive of the SAARC Secretariat, SAARC Chamber of Commerce & Industry, assisted by the National Federations, submitted its draft constitution to the SAARC Secretariat and received its approval in December 1992. This signified the official recognition of the SAARC Chamber of Commerce and Industry (SAARC CCI) by all the national governments of SAARC as the apex body of all the National Federations of Chambers of Commerce and Industry of SAARC as follows:

- Afghanistan Chamber of Commerce & Industry( ACCI)
- Bangladesh Chambers of Commerce & Industry (FBCCI)
- Bhutan Chamber of Commerce & Industry (BCCI)
- Federation of Indian Chambers of Commerce & Industry (FICCI)
- Maldives National Chamber of Commerce & Industry (MNCCI)
- Federation of Nepalese Chambers of Commerce & Industry (FNCCI)
- Federation of Pakistan Chambers of Commerce & Industry (FPCCI)
- Federation of Chambers of Commerce and Industry of Sri Lanka (FC-CISL)

Presently all National Chambers/ Federations of the respective member countries serve as focal points to facilitate the SAARC CCI Secretariat in Islamabad.

### Recognition as an apex body of SAARC CCI:

In recognition of the SAARC CCI's efforts and achievements, the SAARC secretariat, in April 2000, extended its recognition of the SAARC Chamber of Commerce and Industry as the apex chamber of the region for another period of 15 years, instead of a procedure to review this recognition after a period of every 2 years.

The President of the SAARC CCI is now a permanent invitee to the Committee on Economic Cooperation (CEC) of SAARC to give a presentation of the private sector's view points to the commerce secretaries of the seven nations of SAARC.

#### **Headquarters of SAARC CCI:**

The constitution of SAARC CCI designates Pakistan as the Permanent Secretariat of SAARC with a Secretary General to be the Chief Executive Officer of the Secretariat. Soon after the formation of SAARC CCI Headquarters was set up in the premises of FPCCI in Karachi and later on in December 1997 was shifted to Islamabad.

#### **Management & Operations:**

In October 1993, Mr. S.M Inam from Pakistan was elected as the President of the SAARC CCI. In Feb 1994, SAARC CCI was formally inaugurated in Dhaka by the then Prime Minister of Bangladesh. Since its establishment, the Presidency of SAARC CCI has been enjoyed by all seven founder members. Mr. Salman F Rahman of Bangladesh, Mr. Kantikumar R Podar of India, Mr. Qasim Ibrahim of Maldives, Mr. Padma Jyoti of Nepal, Mr. Macky Hashim from Sri Lanka, Dasho Ugen Tshechup Dorji from Bhutan and Mr. Tariq Sayeed from Pakistan,

Mr. Annisul Huq from Bangladesh have so far been the President of the SAARC Chamber of Commerce and Industry.

The Presidency of SAARC CCI rotates amongst the member countries for a two-year term and after completing its circle, the Presidency has been once again handed over to India. Mr. Vikramjith Singh Sahney, is the incumbent President who has assumed the office since January 24, 2012.

### Organs:

The SAARC Chamber shall comprise the following organs:

- a. The General Assembly (also to be known as GA)
- b. The Executive Committee (also to be known as EC)
- c. The General Secretariat

### Objectives:

The objectives of the "SAARC Chamber of Commerce & Industry" are:

- To encourage Trade, Service, Industry, Small & Medium Enterprise, Agriculture, Intra-Regional through creating strong business linkages amongst the entrepreneurs of the region of South Asia
- To make recommendations to safeguard the economic and business interests of the SAARC
- To serve as a consultative body of the Private Sector of the region to provide input/ feed back on regional economic issues
- To encourage Member Countries to accord preferential terms of trade to

- each other and finally strive towards the gradual realization of the SAARC Economic and Monetary Union.
- To promote the exchange of commercial, technical, industrial management and scientific information, education and know-how amongst its members
- To collate, collect and disseminate statistical data and joint research and development among the SAARC Member Countries.

### **Focused Areas:**

The thrust areas for the SAARC CCI can be divided in to five major areas:

- Awareness building on key economic issues i.e. trade facilitation, NTBs, TBTs, Harmonization of Customs Procedures, intra-regional investment and such others pertaining to promote economic cooperation at the regional level
- Develop global linkages as a part of its outreach strategy
- · Provide services to its members and representatives of the private sector
- Work closely with governments, NGOs, CSOs to raise the concern on socio-economic issues
- Develop an institutional framework for supporting economic cooperation

#### Services:

SAARC CCI offers following services:

- Liaison with parent body to exchange views on the areas of activities
- Dissemination of data/information amongst members on socio-economic issues
- To create awareness amongst the stakeholders about economic issues in the region
- To voice concerns of the Private Sector of the region at relevant platforms
- To provide input /feedback of the Private Sector on economic and trade related issues to SAARC Secretariat for policy formulation etc.

Over 500 businessmen, Government officials, celebrated personalities including over 60 member business delegation from Pakistan attended this prestigious ceremony. The Business summit was also addressed by Dr. Shashi Throor, Indian Parliamentarian from Lok Saba, Ms. Shabana Azmi, Ms. Poonam Dhillon, Ms. Sadichha Shrestha, Miss. Nepal, Mr. Vikram Doraswami, JS, Ministry of External Affairs (GoI) and Begum Salma Ahmed from Pakistan also addressed the session on Human Resources Development in South Asia, which was chaired by newly elected President SAARC CCI.

The SAARC Chamber of Commerce & Industry demands Liberal SAARC Visa Policy for Businessmen, substantial reduction in Sensitive list, removal of Para-tariff and Non-Tariff Measures(NTMs) and exhibition of greater political for swift execution of trade facilitation mechanism to ensure accelerated growth in intra-SAARC Trade

Mr. Vikramjit Singh Sahney, President SAARC CCI while making presentation in the 7th Committee of Experts on SAFTA held on 15th February 2012 in Islamabad demanded for revising SAARC Visa Exemption Stickers Scheme (SVES) for the businessmen, which entitled them to acquire SAARC Sticker for one year instead of one month or three months under the new Policy, which was regarded as detrimental to business promotion in South Asia. The SAARC CCI maintained its demands for increase in Stickers to 500 for businessmen of each member state in South Asia.

President SAARC CCI identified 10 basic reasons, hindering the performance of intra-regional Trade in South Asia stating that lack of political will and absence of compatible trade facilitation mechanism, sizeable sensitive list, Para-Tariff Barriers (PTBs) and Non-Tariff Barriers (NTBs) and improper infrastructure were the core issues, which need to be dealt on preferential basis. He proposed several measures like substantial reduction of items under sensitive list, removal of NTBs, imperiously implementation of Multimodal Transport Agreement and representation of Private sector in policy making level to improve the intraregional trade in South Asia. He sought representation of SAARC CCI at Ministerial and


Head of states level. Mr. Tariq Sayeed, Founder and former President of SAARC CCI, Mr. Iftikhar Ali Malik, Vice President, SAARC CCI (Pak) Muhammad Iqbal Tabish, Secretary General, Mr. Zubair Ahmed Malik, former EC Member SAARC CCI were also present during the meeting.

mann Foundation, Fur Die Freiheit, organized a Conference on "Climate Change and Energy Cooperation in South Asia" on April 22, 2012 in Paro, Bhutan.

The Conference was organized under the theme" Climate Change and Energy Cooperation in South Asia", as a response of the Private Sector to these challenging issues and to involve them towards addressing these issues under a regional mechanism.

Hon'ble Prime Minister of Bhutan, H.E. Lyonchen Jigmi Y Thinley inaugurated the conference. Hon'ble Patali Champika Ranawaka, Minister for Power and Energy, Govt of Sri Lanka attended the Conference as guest of honour. Mr. Vikramjit Singh Sahney, President, SAARCI, H.E. # SAARC CCI Conference on Energy, Climate Change and Water Management, Islamabad, Pakistan

The SAARC Chamber of Commerce & Industry (SAARC CCI) in collaboration with Sustainable Development Policy Institute (SDPI) in partnership with Freidrich Naumann Foundation, Fur Die Freiheit, Regional office, New Delhi organized a Conference on Energy, Climate Change and Water Management in South Asia on 30th April 2012 in Islamabad.

The Conference was inaugurated by Dr, Zafar Iqbal Qadir, Chairman, National Disaster Management Authority (NDMA), Government of Pakistan. Senator Dr. Mohammad Azam Khan Swati, former Federal Minister for Science and



# SAARC CHAMBER OF COMMERCE AND INDUSTRY NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2013

## 1. THE CHAMBER AND ITS OPERATION

SAARC Chamber of Commerce and Industry (the Organization) was formed on December 20, 1988 and was given final recognition at SAARC Standing Committees' Seventeenth session held in Dhaka during 7-9 December, 1992. It is a non-trading organization providing services to its members in the field of commerce and industry and promoting intra-regional trade between the member countries.

#### 2. SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies which have been adopted in the preparation of these financial statements are summarized below :-

#### 2.1 ACCOUNTING CONVENTION

These financial statements have been prepared under the historical cost convention.

#### 2.2 BASIS OF PRESENTATION

These financial statements have been prepared in accordance with the requirements of Companies Ordinance, 1984 and approved accounting standards as applicable in Pakistan in all material respects. Approved accounting standards comprise of such International Accounting Standards as notified under the provisions of Companies Ordinance, 1984. Wherever, the requirements of the Companies Ordinance, 1984 or directives issued by the Securities and Exchange Commission of Pakistan differ with the requirements of these standards, the requirements of Companies Ordinance, 1984 or the requirements of the said directives take procedence.

#### 2.3 PROPERTY, PLANT AND EQUIPMENT

These are stated at cost less accumulated depreciation except for land. Depreciation is charged to income by applying the reducing balance method at the rates varying from 10 per cent to 30 per cent. Full year depreciation is charged on additions while no depreciation is charged on deletions during the year.

Maintenance and repairs are charged to income. Major renewals and improvements are capitalized. Gains and losses on disposals, if any, are included in income currently.

#### 2.4 INVESTMENTS

Investments are classified as held to maturity, which are securities with a fixed maturity that the Organization has the intent and ability to hold until maturity.

## 2.5 GRANT FOR CAPITAL EXPENDITURE

Grants utilized for capital expenditure are depreciated on reducing balance method, using rates applied to assets for which they are utilized, to offset the depreciation charged on assets constructed or purchased from such grants.

# 2.6 TRADE AND OTHER PAYABLES

Liabilities of trade and other amounts payable are carried at cost which is the fair value of the consideration to be paid in future for goods and services received.

#### 2.7 REVENUE RECOGNITION

Members' subscription is accounted for on accrual basis.

## 2.8 FOREIGN CURRENCY TRANSLATIONS

Transactions in foreign currencies are translated into rupees at the rates of exchange prevailing on the date of transaction. All assets and liabilities in foreign currencies are translated at the rates of exchange prevailing at the balance sheet date. Exchange differences, if any, are reflected in the profit and loss account for the year.




